Thank you for choosing Little Foxes Forest School LLP. Please see below the Admissions Policy which will provide important information about this provision. Please keep a copy for your future reference.

This setting is open to any child aged: 2.5 to 5 years. No child, individual or family will be unlawfully discriminated against on the grounds of age, disability, gender reassignment, marriage or civil partnership, pregnancy & maternity, race, religion or belief, sex or sexual orientation.

This setting allocates places on a first-come, first-served basis. A waiting list is operated and priorities for places will be:

- 1) Children already attending the setting and requiring additional hours.
- 2) Social Service referrals/ vulnerable children.
- 3) Children of employees.
- 4) Siblings of children currently attending Little Foxes, or siblings of children who have left the setting in the previous academic year.

- 5) Children who have been on the waiting list the longest, are available to take up at least two days, and are willing to pay the chargeable contribution.
- 6) Children who have been on the waiting list the longest, are available to take up at least one day, and are willing to pay the chargeable contribution.

Parents/carers must have completed and signed an up to date registration form and paid the waterproof fee prior to the child attending the setting. If additional support is required for a child to attend the setting, e.g. a support worker or if a child has medication needs, we will work with the parents/ carers and other relevant professionals prior to admission and will aim to accommodate individual needs.

Operational Method

We will offer free hours on the following basis:

- Term Time Only (TTO)- 38 Weeks per year

All about Free Hours

We are registered with Bristol City Council to offer free hours to 2 year olds from working families / Eligible 2 year olds / 3&4 year olds – universal hours / 3&4 year olds – Working Parent Entitlement hours.

2 year olds from working families

Working Parent Entitlement hours are available to children from the term after their 2nd birthday.

Parents must apply via by visiting www.childcarechoices.gov.uk or calling 0300 1234 097 to get an eligibility code (which is 11 digits long and usually starts 500...).

From September 2025, this will be the full 30 Working Parent Entitlement hours per week as we are a term time only setting.

Eligible 2 year olds

Universal free hours are available to some 2 year olds whose parents are on no or low incomes. Parents must apply online for a place with Bristol City Council www.bristol.gov.uk/freeplacefortwos and be checked for eligibility before a free place can be offered.

Eligible 2 year old free hours are available to eligible children from the term after their 2nd birthday. From September 2025 some parents will be able to use both Eligible 2 year old universal hours and Working Parent Entitlement hours at the same time, prioritising their Eligible 2 year old universal hours first.

We will be able to offer 15 universal free hours per week.

3 and 4 year olds – Universal hours

Universal free hours are available to all children who are 3 or 4 (as long as they are living in England). Free hours are available to all children from the term after their 3rd birthday.

We will be able to offer 15 universal free hours per week.

3 and 4 year olds – Working Parent Entitlement hours (from working families)

The Working Parent Entitlement hours are available to children who are 3 or 4 children from the term after their 3rd birthday. Parents must apply by visiting www.childcarechoices.gov.uk or calling 0300 1234 097 to get an eligibility code (which is 11 digits long and usually starts 500...).

We will be able to offer 15 Working Parent Entitlement free hours per week.

Parents of 3 and 4 year olds can use both universal and Working Parent Entitlement free hours in combination (i.e. 30 free hours per week)

Eligibility Codes (for working families)

- Eligibility codes need to be reconfirmed every 3 months. The eligibility code will remain the same after reconfirmation. It is the parent/carer's responsibility to keep their child's eligibility code valid at all times.
- Verification checks will be made on Bristol City Council's Provider Portal, using the following data:
 - a. Your 11-digit eligibility code
 - b. Your National Insurance Number(s)
 - c. Your child's date of birth
 - d. Your written consent(s) from your signed EYR1 Parental Declaration Form to verify eligibility.

Once the code is verified, you will be contacted to discuss sessions.

- Grace Periods – If you do not reconfirm the eligibility code and the code becomes invalid, the 'grace period' starts. The grace period is a short period of time where a child can still access their Working Parent Entitlement / free hours. Once the grace period has expired:
 - ❖ 2 year olds from working families will have to pay for all childcare provision privately but may be eligible to apply for an Eligible 2 year old place if they meet the criteria (see above for the weblink).
 - ❖ 3 and 4 year olds from working families will only be able to access their universal free hours and must pay for any additional childcare provision.
- If this happens, we will discuss what to do about the sessions you have lost. Codes which are already in their grace period must be reconfirmed before claims can be made for Working Parent Entitlement.

- Bank Holidays are not funded by Bristol City Council. If your free hours fall on a bank holiday, the free session will not be rescheduled.

All about Payments

Waterproof Starter Fees

We charge a non-refundable waterproof starter fee of £100 which must be paid in order to secure your child's place at the nursery. In return you will receive a brand new Didriksons Slaskeman set of waterproofs before they start. This will be either red or yellow depending on whether your child is in ladybirds or bumblebees group.

Tax Free Childcare (for paid childcare and consumables)

We are registered to offer Tax Free Childcare. Parents can check eligibility and apply for Tax Free Childcare via www.childcarechoices.gov.uk. Tax-Free Childcare is the system that is gradually replacing the old childcare voucher scheme - paying for childcare through the employer.

Invoicing

You will be invoiced on a monthly basis. Your invoice will clearly detail your funded sessions, as well as the consumables charge that will apply in addition to the funded session to cover food, drinks and trips etc.

If you do not use the funding your invoice will state the daily "unfunded" charge and this will include all food, drinks, trips etc.

In order to calculate a child's funded hours we would use the following formula: 570 hours / 38 weeks = 15 hours per week.

This is optional for all families, however if you do opt out of this charge we cannot offer your child any of the consumables including the enhanced trip ratio of 1 adult to 4/5 children whilst in the forest. We need the enhanced ratio to keep your children safe whilst in the forest. Therefore, for families opting out of the consumables charge we can no longer offer you forest sessions. You would also need to provide packed lunches, and pay additional charges for your child to access the range of trips, parties and enrichment sessions that we run throughout the year. We will only be able to offer your child indoor sessions where we have a larger ratio.

We will include the charge on your usual invoice, but please come and speak to a member of staff if you wish to opt out. Parents will be asked to make a termly commitment for all chargeable items as stated in the EYR01 Parental Declaration form. Please note that parents who agree to pay the chargeable items are prioritised for admission into Little Foxes.

To support the payment of chargeable items and private hours, working parents can use their Tax Free Childcare Allowance. For families claiming [Universal Credit](#), there is up to 85% government support for all childcare costs, and you can claim in advance!

Chargeables

The below table shows a breakdown of the chargeable hourly rate. The hourly rate is shown in green and is reviewed annually. The costs below are illustrative of how the rate is calculated across the setting. Where possible we have tried to reduce the hourly charge to ensure affordability for our families.

Voluntary Contribution

In order to maintain a sustainable business model we have greatly appreciated the number of families who have supported us by paying a voluntary contribution over the past few years. This has ensured the survival of Little Foxes.

Continuing to support us through a voluntary contribution enables us to continue to pay our amazing team the National living wage. This is well below the level that this highly qualified group of individuals deserves but it's still not attainable with the funding provided from the government and the ratio we provide your children. We can only pay the national living wage to our team with your support through the voluntary contribution. We appreciate that in the current financial climate that this is unmanageable for some of you. At the point of registration, we will therefore ask you to opt into band A or B of the voluntary contribution.

Payments from 3rd Parties (Colleges and Universities)

Free hours cannot be claimed at the same time that they are paid for by a third party. We will need to receive written confirmation as soon as possible can work out which hours are **a)** paid by the college / uni, **b)** covered as free hours and **c)** paid for by you. Student parents may not always be eligible for Working Parent Entitlement/ Working Parent Entitlement childcare unless they meet the eligibility criteria found here www.childcarechoices.gov.uk

Sibling Discount

Sadly we are unable to offer a sibling discount.

Late Collections

We charge £15 for the first 10 minutes a child is collected late. For every minute after this we will charge £5 a minute until the child is collected. This will be added to your invoice.

Notice Periods

Parents are asked to make a termly commitment. This means that once parents sign the EYR01 Parental Declaration Form a contract is made. If parents then decide to transfer to another provider, funding will not always be re-directed to your new childcare provider until the start following term (Sept, Jan, April). The only group who can give a shorter notice period are Eligible 2 year olds who only need to give 1 months' notice. Please approach us directly to discuss this. Our 6 week notice period applies when letting us know about leaving the setting and if you wish to reduce your hours. A 13 termtime week notice period applies to confirming your child's hours for a subsequent year. For example, we will need notice of any reduction in your requested September 2026 hours by 20th April 2026
